The Non-Proliferation Treaty system is frequently tested and challenged especially when questions of compliance and enforcement arise. The United States is taking steps with international colleagues to build an international framework for civil nuclear cooperation. Such a framework could rely on a combination of government and industry commitments to reassure states in compliance with their nonproliferation obligations that all of their nuclear fuel servicing needs can be met by the commercial marketplace without fear of disruption.
