Today's Innovators

- Charley Martin-Berry is the Executive Director of Community Caring Collaborative (CCC) in East Machias, Maine. She
 helped shape and launch Family Futures Downeast (FFD), a two-generation education and workforce opportunity for
 families. FFD was designated as one of 10 White House Rural Council Rural IMPACT Demonstration sites (2015-18)
 nationwide. Charley acts on the values of the Community Caring Collaborative to increase health and hope in
 Downeast Maine, focusing on strengthening partner organizations and their collective impact.
- Duane Yoder is the President of Garrett County Community Action Committee (GCCAC) in Oakland, Maryland.
 GCCAC is a nationwide leader in implementing a whole-organization 2Gen strategy to help low-income families move from crisis to thriving, inspiring both rural and urban sites across the country. Also designated a White House Rural Council Rural IMPACT Demonstration site, GCCAC serves nearly 33 percent of households and 25 percent of residents in its far western Appalachian Maryland county.
- Shannon Davis, a Maryland native, is a young mother who has lived in Garrett County for 15 years. One of four children from a family plagued with poverty and addiction, Shannon was homeless, pregnant and still struggling with substance abuse when she walked into the doors of Garrett County Community Action Committee in September 2017, with the goal of finding housing and stabilizing her family life.

- Jeannie Chaffin helps design policy and implementation strategies that can improve family livelihoods. As recent director of the Office of Community Services (OCS) in the Administration for Children and Families, U.S. Department of Health and Human Services, she helped lead the 2017-19 national Rural IMPACT Demonstration. Now an independent consultant, Jeannie is currently helping the national Community Action Partnership's learning communities as they adopt 2Gen practices and transition toward becoming 2Gen organizations; and she is advising on 2Gen policy in several states.
