Inconsistent asset limits and income cliffs create real barriers for people wanting to take a new job or promotion, creating real friction for people trying to move from public to workplace benefits. Addressing each of these pieces in ways that make the whole system work for workers and families requires committing to a shared vision among institutions and across sectors.

You have been invited to this forum alongside all the other leaders here because you have the passion, ability, and curiosity to build and scale the solutions to these problems. We are grateful to all of you for joining us and your ongoing and future work to support the financial security of everyone in America. We would like to especially thank the financial supporters of the Forum, without whom this gathering would not have been possible. We hope that this Forum can launch partnerships between participants, illuminate and clarify ideas that you can use to solve problems at home, and help us collectively develop the scope of work we can pursue together. Most importantly, we hope that your experience at this year's Forum will expand your view of what is possible for the future of benefits across the U.S., as well as what your role in leading this change can be.

Shelley Banker is a leader passionate about challenging inequities, disrupting social injustice, and empowering communities. As the Director of the Office of Economic Security, she leads a team working to improve policies and statewide support systems, eradicate poverty through child support, food and energy, and cash programs via a \$685 million dollar budget. She has over a decade in nonprofit, private, and public sectors promoting educational equity and access in Colorado's postsecondary systems, including through the implementation and expansion of the Colorado Opportunity Scholarship Initiative (COSI), and the establishment of the Colorado Department of Higher Education's Educational Equity Office and Equity Champions Coalition. Shelley received her MSW from the University of Denver's Graduate School of Social Work and a BS in Business Administration from the University of Colorado Denver. She serves on the Denver CASA Board of Directors, and enjoys showing her daughter everything nature offers.

Executive Director, Colorado Department of Labor and Employment

In December 2018, Governor Polis appointed Joe Barela as the Executive Director of the Colorado Department of Labor and Employment, a 1900-person state agency housing the Divisions of Unemployment Insurance, Workers' Compensation, Labor Standards and Statistics, Vocational Rehabilitation, Employment and Training and Oil and Public Safety. Joe has more than 25 years of experience in workforce and human capital development and is seen as a local and national leader in the field. Joe is passionate about creating more opportunities for better career pathways for working all Americans. Under his leadership he has introduced the Office of the Future of Work, The Office of New Americans and the Office of Just Transitions as well as the Colorado Family and Medical Leave Insurance Division.



Reggie BichaPresident & CEO, **American Public Human Services Association (APHSA)**

Reggie Bicha, MSW, is a social worker, administrator, educator, and national leader. He has extensive experience working on child welfare, early childhood education, employment, and healthcare issues at the county, state, and national levels. He served as the Executive Director for the Colorado Department of Human Services for Governor John Hickenlooper, and as the Inaugural Secretary of the Wisconsin Department of Children and Families for Governor Jim Doyle. He is a former Ascend Fellow, sponsored by the Aspen Institute, focusing on 2 Generation approaches to move children and parents beyond poverty. Reggie served as President of Acelero, Inc., a pioneering provider of early childhood education and family engagement services for thousands of Head Start children and families across the country. Reggie was recognized in 2014 for his leadership and dedication with the Casey Family Programs "Excellence for Children Award." Reggie has three children and lives with his wife, Katie, in Denver, CO.



Lelaine BigelowExecutive Director, **Georgetown Center on Poverty and Inequality**

Lelaine Bigelow is the Executive Director of the Georgetown Center for Poverty and Inequality. She leads work to expand economic security and opportunity and advance racial and gender equity for everyone through engagement, research, analysis, and ambitious policy ideas. A longstanding leader in the paid leave movement, Lelaine came to GCPI after serving as vice president for social impact and congressional relations at the National Partnership for Women & Families, where she was responsible for creating and executing strategies to turn policy work into social change. Her accomplishments include passing the Federal Employee Paid Leave Act (FEPLA) and the Pregnant Workers Fairness Act (PWFA). She ran a major national campaign for paid family and medical leave that included a broad coalition of workers and business and bipartisan leaders across the country. Lelaine has extensive experience working in government as Deputy Assistant Secretary at the Department of Housing and Urban Development during the Obama Administration and in Congress, including roles with Rep. Judy Chu (D-CA) and the Congressional Asian Pacific American Caucus, Rep. Corrine Brown (D-FL), and Rep. Jerrold Nadler (D-NY). Lelaine graduated from the University of Florida and the Graduate School of Political Management at George Washington University. In 2012, she was named a Champion for Children by First Focus and established a National Commission on Children and Disasters in 2008.



Meg BoothDirector, Health Essentials, **AARP Foundation**

Meg is the Director, Health Essentials on the Financial Well-Being Team at AARP Foundation. Her team is focused on improving the affordability and accessibility of food, medicine, and health care for and with older adults with low income. 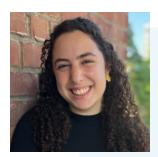
André LimaDirector for the US, **Open Contracting Partnership**
